VIOR : SHARES ISSUED TO FONDS DE SOLIDARITÉ FTQ

QUÉBEC, CANADA, JULY 27, 2010 – SOCIÉTÉ D’EXPLORATION MINIÈRE VIOR INC. (TSX VENTURE (VIO), FRANKFURT (VL5) –announces that, subject to the TSX Venture Exchange approval, Vior will issue 75,087 common shares at deemed price of \$0.07925 per share to Fonds de solidarité FTQ (“FTQ”) representing the interest due (totalling \$5,950.68) as of July 17, 2010, pursuant to a private placement by way of convertible debenture in the principal amount of \$100,000 on July 17, 2009, that bears interest at the rate of 12% per annum, payable semi-annually in cash or in common shares from Vior’s capital stock.
